Open Public Hearing: -CR&R Presentation -Receive public comments regarding the Solid Waste rate increase

Esteban Padilla, 1078 Heber Ave- Mr. Padilla stated that he is not in favor of this potential trash increase. He has experienced bad service from CR&R and does not feel that CR&R should be compensated.

Isidro Cuen, 6 Dove Ct- Mr. Cuen stated that he is not in favor of this potential trash increase. He stated that \$24.00 a year is extensive and that many families would not be able to afford a serious rate increase.

Sarah Curry, 59 W Mallard St- Ms. Curry stated that she is not in favor of this potential trash increase. She has had bad service from CR&R in the past and has dealt with many trash and oil spills.

Close Public Hearing: After receiving comments from the public regarding the proposed Solid Waste rate increase.

Clerk of the Board, Moises Cardenas, stated that there was a total of 46 written protests turned in prior to the Regular Board meeting, and 2 were submitted during the board meeting, totaling 48 written protests. HPUD needed a total of 842 to not implement the rates according to Proposition 218, which were not met at this public hearing.
