SUBJECT: Adopt Resolution 2017-12 Approving a Payment Schedule to Ensure the Wastewater Fund Repays the Parks Fund for Monies Owed Over a Ten Year Period

ISSUE:

Shall the Heber Public Utility Board of Directors adopt Resolution 2017-12 approving a payment schedule to ensure the wastewater fund repays the parks fund for monies owed over a ten year period?

GENERAL MANAGER RECOMMENDATION:

Adopt Resolution 2017-12 approving a payment schedule for monies owed from the Wastewater Fund to the Parks Fund.


FISCAL IMPACT:

Adopt Resolution 2017-12 will not have an impact on the FY 2017-18 budget as the first payment will not start until 2018-19.

The total amount due from the Water Fund to the Wastewater fund is \$48,828 annually.

DISCUSSION:

In 2007, Pacific Century Homes donated two parcels to the Heber Public Utility District under the condition that the HPUD develop a park. The two parcels are identified on the map below.



One parcel was developed into what is now called Jiggs Johnson Park. The other parcel was transferred from the Parks and Recreation Fund Asset List to the Wastewater Fund Asset List. This was done as an internal transfer and no money was transferred for the value of the asset, and no liability was recorded to indicate that the wastewater fund owes the parks fund for the value of the asset.

The Resolution before you is intended to correct this transaction and establish a liability in the wastewater fund and a revenue in the parks fund.

At the time of the asset transfer, the asset had a market value of \$488,276. The attached page of the HPUD Financial Statement for 2010 shows this asset value being moved from Governmental Activities (Parks and

Recreation) to Business Type Activities (in this case the wastewater fund). The Resolution establishes a payment plan over ten year with zero percent interest. This allows the wastewater fund to pay the parks fund the entire asset value over a longer period of time. The first payment will not start until FY 2018-19, thus a budget amendment for FY 2017-18 will not be needed. The payment will be included in the next Fiscal Year budget.

CONCLUSION:

This transaction was made in 2010 and should be corrected to ensure that the Parks Fund is made whole. Staff recommends adopting Resolution 2017-12 establishing a payment plan to repay the Parks Fund over a ten year period with zero interest.

ALTERNATIVES:

- a) Adopt Resolution 2017-12 with changes to the terms and conditions of the repayment schedule.
- b) Do not adopt Resolution 2017-12, which will postpone the correction to the 2010 transaction.
- c) Provide alternate direction to staff.

RESOLUTION NO. 2017-12

A RESOLUTION OF THE HEBER PUBLIC UTILITY DISTRICT APPROVING A PAYMENT SCHEDULE TO ENSURE THE WASTEWATER FUND REPAYS THE PARKS FUND \$488,276 IN MONIES OWED OVER A TEN (10) YEAR PERIOD BEGINNING FY 2018-19

Whereas, in 2007 the Heber Public Utility District Parks and Recreation Fund accepted two parcels of land, which were donated by Pacific Century Homes; and

Whereas, the Heber Public Utility District Parks and Recreation Fund expended monies to develop one of the parcels, identified as APN#054-605-010-000, into a park, which is now known as Jiggs Johnson Park; and

Whereas, in 2010 the Heber Public Utility District transferred ownership of one parcel, identified as APN# 054-605-008-000, from the Parks and Recreation Fund to the Wastewater Fund, which was accomplished by moving the asset value of the parcel from the Parks and Recreation Fund to Wastewater Fund, which was identified on the Heber Public Utility District Asset List, and Audited Financial Statements; and

Whereas, the Wastewater Fund did not compensate the Parks and Recreation Fund for the value of the parcel; and

Whereas, the parcel, which was transferred from Parks and Recreation to Wastewater, was valued at \$488,276. This valuation was provided by the Imperial County Assessor's Office and in 2010.

Whereas, the Wastewater Fund has sufficient reserve funds and annual revenues to guarantee payment to the Parks and Recreation Fund through annual inter-fund transfer payments; and

Whereas, the Heber Public Utility District desires to implement a payment schedule to ensure the Wastewater Fund repays the Parks and Recreation Fund the full amount, without interest, in equal payments over a ten year period.

Now Therefore, the Heber Public Utility District does resolve to:

- 1) Make annual Inter-Fund Transfers from the Wastewater Fund to the Parks and Recreation Fund, and
- 2) to include this transaction in the budgets according to the following schedule:
