

RESOLUTION NO. 2016-5

A RESOLUTION OF THE HEBER PUBLIC UTILITY DISTRICT ADOPTING THE FEE AND CHARGES SCHEDULE FOR THE USE OF DISTRICT PARKS, BUILDINGS AND FACILITIES

WHEREAS, the Heber Public Utility District (HPUD) Board of Directors is charged with balancing cost recovery with the community's affordable access to parks, buildings and facilities; and

WHEREAS, the HPUD acknowledges that affordability is the foundation for all recreation service delivery including access to parks, buildings and facilities within the HPUD service area; and

WHEREAS, it is the responsibility of HPUD to establish fees to recover costs associated with the specific use of public facilities needed to provide services; and,

WHEREAS, the HPUD Board of Directors desires to create a Fee Schedule, which is attached to this Resolution as Exhibit "A" and titled "Heber Public Utility District Fee and Charges for use of District Parks, Buildings and Facilities Policy Number 3756"; and

WHEREAS, these fees have been determined based upon the HPUD's costs to review applications, monitor operations for the purpose of promoting public health, safety and welfare in District owned facilities, and the actual cost of providing lights, electricity and other materials directly related to the facility use; and

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Board of Directors of Heber Public Utilities District as follows:

1. That the foregoing is true, correct and adopted.
2. That the HPUD Board of Directors hereby adopts the Fee and Charges for use of District Parks, Buildings and Facilities Policy Number 3756, which is attached hereto as Exhibit "A" and made a part hereof a Policies and Procedures Manual.

3. That all actions by the Board of Directors of the Heber Public Utilities District heretofore taken pertaining to the subjects covered in the Fee and Charges for use of District Parks, Buildings and Facilities Policy Number 3756 are hereby repealed.
