Subject: January 2024 Monthly Report

On the billing cycle ending on the 20th of January 18,135,000 million gallons of water were used by our consumers, an average of 604,000 thousand gallons was used per day.

On January 10, 20234 collected the 1st quarter Trihalomethanes (TTHM's) and Haloacetic Acids (Haa5) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on January 29, 2024 and were once again below the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 57 ppb for the Mc Cabe site and 43 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.

On January 31, 2024 the mixer for the 3-million-gallon tank TTHM removal system was installed and is now operational. The mixer and electrical connections were completed by HPUD staff.
