- A. Major violations: (NONE) On January 9, 2023 an oil and grease sample was collected and exceeded the limit of 25mg/l. We collected another oil grease sample on 2/27/2023 and there was no oil and grease detected.

Subject: March 2023 Monthly Report

On the billing cycle ending on the 23rd of March 14,912,000 gallons of water were used by our consumers, an average of 514,000 gallons was used per day.

On March 16, 2023, collected Trihalomethanes (TTHM's) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on March 27, 2023 and were below the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 58 ppb for the Mc Cabe site and 46 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.
