- F. Vactor Truck: November 23, 2022 vactor truck was used to clean out the north train aeration basin at the wastewater plant. On December 5, 2022 vactor truck was used to clean out the north anoxic basin at the wastewater plant. On December 21 and 22, 2022 the vactor truck was used to expose a water line on Valley and Crane lane.
- G. TOTAL OF MILES OF SEWER LINES CLEANED OR VIDEOED: 0 miles. The rehab manhole project On Correll street has been completed.
- H. From November 23, 2022 through December 23, 2022: Heber Wastewater Plant received and treated <u>12.914</u> MG.
- I. HPUD did not exceed the daily maximum flow (1.2 MGD) as of December 23, 2022.
- J. Updates: The Heber Public Utility District Wastewater Treatment has been recently having PLC and electrical equipment failures at the headworks control building, due to old and outdated equipment. Our headworks control room is also exposed with hydrogen sulfide gas which corrodes and shortens the lifespan of the equipment. We currently have most of our treatment plant equipment on manual instead of being on automatic the way the plant was designed to be operated. A short term fix is to contract our instrumentation tech to pin point the problem. The Heber Public Utility District has been spending a vast amount of money to keep repairing our PLC and electrical issues. We have been consulted by Delta Systems engineering that we need to upgrade our PLC and SCADA system to avoid costly repairs.

Subject: December 2022 Monthly Report

On the billing cycles ending on the 21st of December 16,718,000 gallons of water were used by our consumers, an average of 557,000 gallons was used per day.

On December 15, 2022, collected the monthly Trihalomethanes (TTHM's) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on December 28, 2022 and were below the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 58 ppb for the Mc Cabe site and 47 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.
