

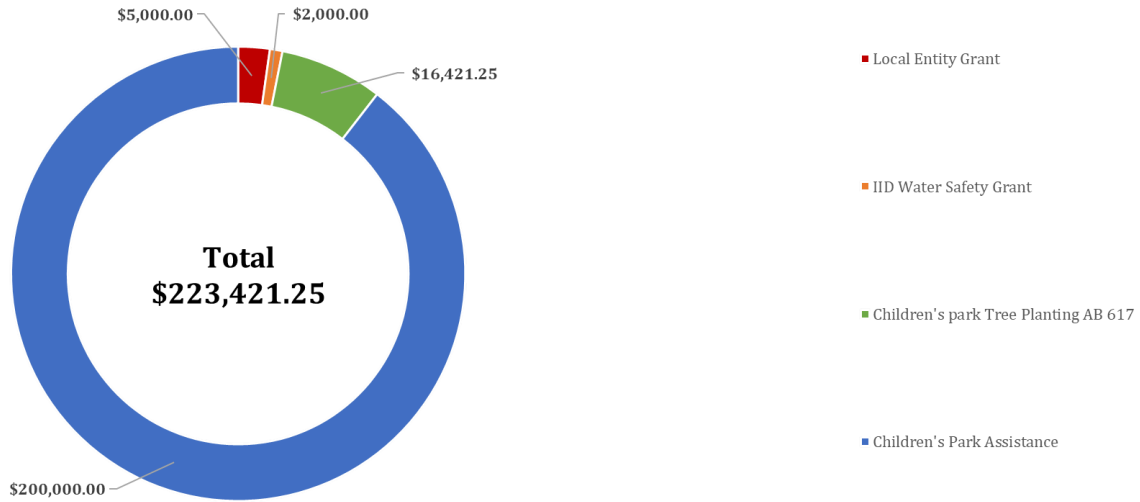

## Local Grants



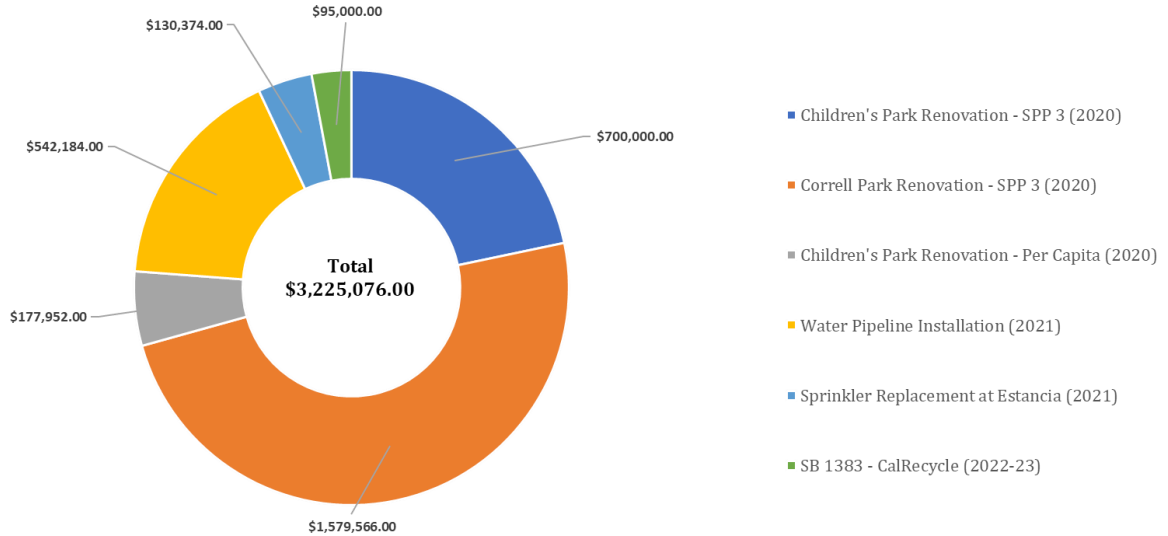
 Children's Park will commence the tree planting project upon completion of splash pad construction

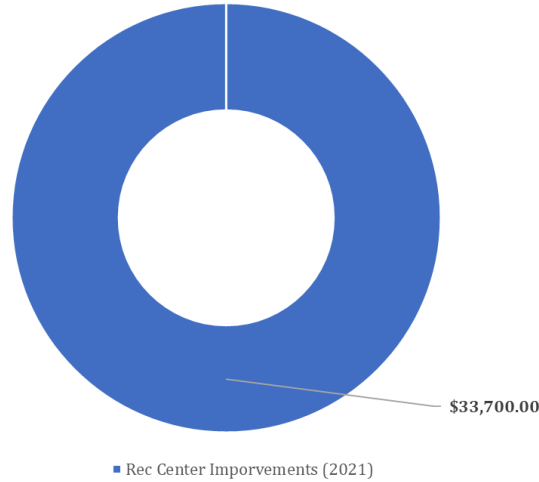

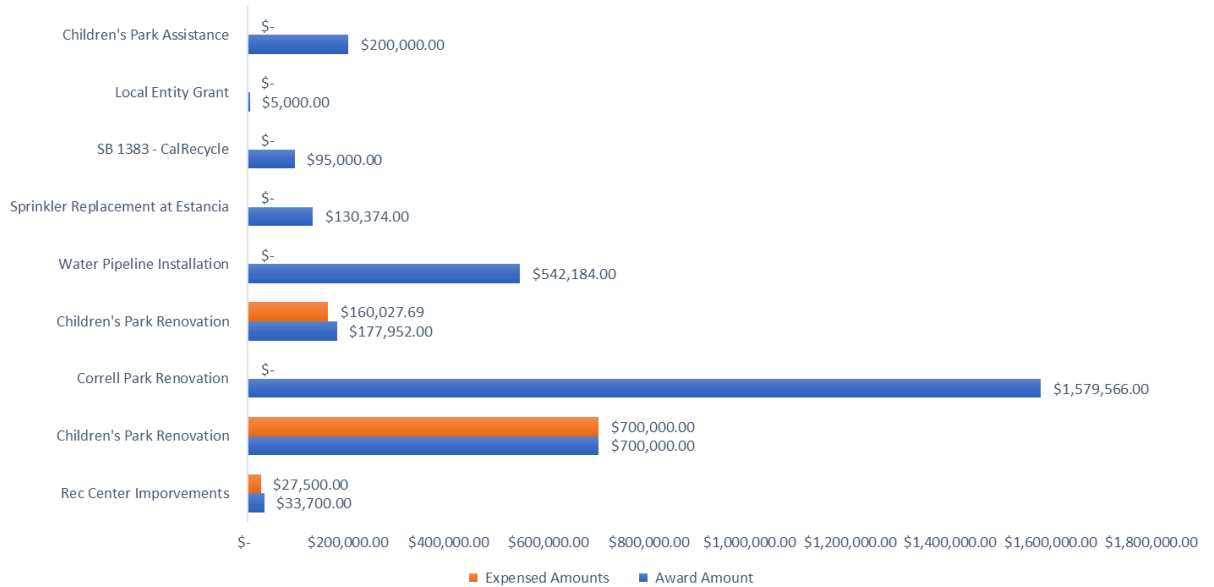


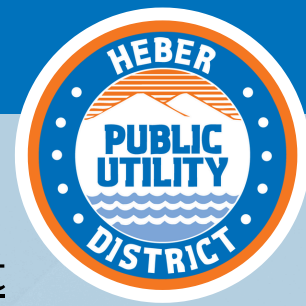
## Federal Grants
