HPUD OPERATIONS

Staff met with our engineers at The Holt Group and reviewed several projects.

USDA Projects –

Memo to BOD 11/17/2022

• Recreation Center Patio. This project has been awarded to A&N Construction for design bid. We have reviewed the design and anticipate construction to start within a month.

Department of Water Resources -

- Water Line in alley south of Main Street to Heffernan Avenue. This project is being designed by The Holt Group.
- Sprinkler System at Estancia. Staff is working on the bid documents.

HPUD Projects –

- Water line in the Courts. Juny will present an update on this project at the November meeting.
- Flow Meter at the Water Treatment Plant. The Holt Group received one bid and is trying to secure another prior to bringing this project to the Board.
- Manhole Repair and Replacement. This project is complete.
- IID meter at the gate. The Holt Group and staff are working to determine the best location for the installation of the mandated meter.

Parks Grant Projects –

- Children's Park. This project is on hold to determine if we can secure additional funding. The Heber Community Foundation awarded HPUD \$200,000 grant funds to put towards this project. The Board approved a hold until December 2022.
- Correll Park. This project design has yet to be started. We have secured a deed restriction.

Development Projects –

- Miraluz I received a letter from Miraluz stating that the project is seeking funding, but will move forward through the planning process.
- Dollar General The lot split is moving through the review process.
