Dear Vendor/Supporter,

The Heber Public Utility District is celebrating Spring with our Easter Egg Hunt Event. Our Easter event is planned for Thursday, April 6, 2023. The event starts at 4:00pm at Tito Huerta Park. We are looking for vendors who want to participate in a community based event to further their fund raising efforts. We anticipate a large crowd due to free Easter Egg Hunt that the Heber Public Utility District will be providing.

All food booths are encouraged to incorporate the Easter Egg and Bunny theme. The Heber Public Utility District will manage the sign ups and health permits for the vendor booths.

## **Booth Details**

- Each vendor booth space is 15' x 15' if you require additional booth space it must be purchased. Event space is limited so the booth space requirement will be strictly enforced.
- There is no electricity available at the site vendors must provide their own electrical power. Quiet or silent generators and propane heaters are permitted for heating purposed but will be used at the discretion and responsibility of the vendor using them.
- No equipment or lights will be provided vendors must provide their own equipment (lights, tents, tables, chairs, grills, stoves, cooking equipment, utensils, etc)
- Vendors are responsible for all costs, labor, materials, equipment, tenting, supplies and any other items necessary for participation in the event.
- It is recommended that each vendor bring a trash receptacle and garbage bags as well as ample cash change for sales.
- Food vendors must submit a completed Imperial County Health Department Food Permit application to Heber Public
  Utility District by March 22, 2023. Heber PUD will submit the completed Health Department Food Permit
  Applications to the County.
- The Food Permit must be displayed on the booth and be visible to the public during the event.
- We encourage you to decorate your booth! Be creative!
- No outside entertainment within booths (Bands, Karaoke, Singers, Radio, etc)
- The Heber Public Utility District reserves the right to assign vendor spaces and will do our best to meet any special needs or requirements.

#### Set-Up

- Vendor can setup anytime after 10:00am on Thursday, April 6, 2023. Vehicles may be brought into the event space during setup, but must be removed by 2:30pm. **VEHICLES MUST BE REMOVED BY 2:30pm**
- No vehicle parking will be allowed on Palm Avenue between Sparrow and Hawk Street.
- Vendors must be open and be ready for Health Department inspection by 4:00 PM.
- Vendors may be open and ready to sell food/products or distribute information by 4:00 PM.
- You can close your booth after 9pm. You can carry your supplies out, but ABSOLUTELY NO VEHICLES on Palm between Sparrow and Hawk until after Midnight.
- Vendors will be responsible for cleanup within their assigned space and will be expected to do so immediately.
- We anticipate a good crowd as early as 4:00 PM and encourage vendors to be up and ready for these potential customers. The Easter Egg Hunt starts at 6:15pm followed by entertainment.

### **Costs & Application Information**

Fees vary depending on your organization and the purpose of hosting the booth. The fee's are:

- \$20 For Organizations selling food. You MUST have enough food or product to last the entire time of the event.
- \$10 For anyone selling non-food items. All food items must have a County Health Permit.
- \$5 For Individuals and Organizations providing information only (no selling)
- Free For Non-Profit Organizations. Must show proof of Non-Profit status and must preregister.
- Anyone not registered with the Heber Public Utility District by the deadlines listed above will not be allowed to participate.

Entry fee must be received at the time of application. No credit can be extended. All checks must be made payable to Heber PUD. No refunds will be made to those vendors who cancel.
