Subject: December Monthly Report

On the billing cycle ending on the 26th of December 28,235,000 gallons of water was used by our consumers, an average of 856,606 gallons was used per day.

On December 17, 2013 a bob cat was rented to aid in the cleaning of pond #3. The sludge was pushed with the bob cat toward the north end of the pond and then pumped with the 6" pump to the drain parallel to Dogwood Canal. On December 23, 2013 Pond #3 was placed back into service.

On December 24, 2013 Pond #3 raw water overflowed due to operator unintentionally leaving a gate valve closed. Raw water flowed into the alley and into an empty lot. The water was pumped into the sewer to speed up the drying and gravel was also spread over the affected areas to facilitate access to customers. This incident did not cause any water quality issues or violations.


