Subject: March 2021 Monthly Report

On the billing cycle ending on the 23rd of March 20,140,000 gallons of water were used by our consumers, an average of 671,000 gallons was used per day.

On March 4, 2021, collected Trihalomethanes (TTHM's) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on March 17, 2021 and were below the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 56 ppb for the Mc Cabe site and 45 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.
