Energy Audit

The energy audit consultant was on site last week (following COVID guideline) he set up a data logger. They are setting up a time during the week of April 19th to review the data and discuss potentials measures of interest, which we can do remotely.

Water and Sewer Master Plan

This project should be completed within the next few months. We have finished review and are waiting for the consultant Michael Baker to respond.

NPDES Permit at Wastewater Treatment Plant

No new update. We (THG and HPUD Operations Staff) have submitted (in late December 2020) the Wastewater Treatment Plant's National Pollution Discharge Elimination System (NPDES) Permit application to the Regional Water Quality Control Board. We expect to receive comments within the next couple of months.

Sewer System Management Plan

Juny will submit the draft next week for review by HPUD staff. It will need to be reviewed by HPUD and approved by the Board prior to submittal to State Water Resources Control Board. He still needs to work on a couple of attachments. This will be ready for the May agenda.

Updates to State's Blueprint Allows Imperial County to Move to Orange Tier *Vaccine Milestones Allow for Broader Reopening*

IMPERIAL COUNTY – State of California Health Officials announced today that California has successfully administered 4 million doses of COVID-19 vaccine to the most underserved communities throughout the State. Reaching this milestone allows broader reopening and paves the way for Counties to advance more quickly through the California Blueprint for a Safer Economy. Based on the updated guidance, Imperial County can now move to the Moderate or Orange level of the State’s Tier System. Changes go into effect Wednesday, April 7, 2021. In total, over 33% of California residents have received at least one dose of the COVID-19 vaccine (over 19 million doses administered). Locally, nearly 71 thousand doses of first and second doses combined have been administered.

“The fact that the number of COVID-19 vaccines available and being administered throughout California is increasing is exceptionally good news,” stated Dr. Stephen Munday, Imperial County Health Officer. “Getting the vaccine and continuing to follow safety precautions is our quickest path forward. I’m extremely proud of those in our community who have chosen to get the COVID-19 vaccine and encourage those who have not yet gotten it to enroll to receive it as soon as it becomes available.”

The following is an abbreviated list of services and activities allowed under the Orange Tier. For a full list of activities and required modifications, please see the [Blueprint for a Safety Economy Activity and Business Tiers table](#).

- Bars (where no meal is served): Open outdoors with modifications.
- Family entertainment centers: Open indoors with modifications. Max capacity 25% or 50% if guests are tested or show proof of full vaccination.
- Fitness centers and gyms: Open indoors with 25% max occupancy; indoor pools open at 25% occupancy.
- Movie theaters: Open indoors with 50% max occupancy or 200 people, whichever is fewer.
- Offices: Open indoors with modifications though telework is still encouraged.
- Places of worship: Open indoors with 50% max occupancy.
- Retail (including standalone grocers): Open indoors at full capacity with modifications.
- Restaurants: Open indoors with 50% max occupancy or 200 people, whichever is fewer.
- Shopping centers (including swap meets and indoor malls): Open indoors at full capacity with modifications; common areas must remain closed and food courts are at reduced capacity.
- Outdoor live events w/assigned seating: In-state visitors only. Max 33% capacity or 67% if all guests are tested or show proof of full vaccination.
- **Effective April 15th:** Indoor Seated Live Events and Performances: In-State visitors only. Modification and capacity limits based on venue size apply.
- **Effective April 15th:** Private Events: Outdoor - Max 100 people or 300 if guests are tested or show proof of full vaccination.

Actualizaciones al Plan de California Permite que el Condado de Imperial Pueda Moverse a Nivel Naranja
El Cumplimiento de Metas de Vacunación Permite Reaperturas Mas Amplias

CONDADO DE IMPERIAL - Los funcionarios de salud del estado de California anunciaron hoy que California ha administrado con éxito cuatro millones de dosis de la vacuna COVID-19 a las comunidades más desatendidas en el estado. Alcanzar esta meta permite una reapertura más amplia y abre el camino para que los condados avancen más rápidamente a través del Plan de California para una Economía más Segura. Según la guía actualizada, el Condado de Imperial puede pasar al nivel Moderado o Naranja del sistema de niveles del estado. Los cambios darán inicio el miércoles siete de abril de 2021. En total, más del 33% de los residentes de California han recibido al menos una dosis de la vacuna para COVID-19 (más de 19 millones de dosis han sido administradas). A nivel local, se han administrado cerca de 71 mil dosis de la primera y segunda dosis combinadas.

“El hecho de que la cantidad de vacunas COVID-19 disponibles y que se administran a lo largo de California esté aumentando es una noticia excepcionalmente buena”, afirmó el Dr. Stephen Munday, Oficial de Salud del Condado de Imperial. “Recibir la vacuna y continuar con las precauciones de seguridad es el camino más rápido a seguir. Estoy extremadamente orgulloso de aquellos en nuestra comunidad que han elegido recibir la vacuna COVID-19 y animo a quienes aún no se han vacunado a inscribirse para que les sea aplicada tan pronto como esté disponible.”

- Bares (donde no se sirve comida): Abiertos al aire libre con modificaciones.
- Centros de entretenimiento familiar: Abiertos en el interior con modificaciones. Ocupación máxima de 25% o 50% si los asistentes han recibido un examen negativo o tienen prueba de haber recibido la dosis completa de vacunación.
- Centros de fitness y gimnasios: Pueden abrir en interiores con un 25% de ocupación máxima; piscinas interiores al 25% de ocupación.
- Cines: Abiertos en interiores con un 50% de ocupación máxima o 200 personas, lo que sea menor.
- Oficinas: Abiertas en el interior con modificaciones, aunque todavía se fomenta el trabajo a distancia.
- Lugares de culto: Abiertos en interiores con un 50% de ocupación máxima.

- Tiendas departamentales (incluidas las tiendas de comestibles o mercados): Abierto en interiores a plena capacidad con modificaciones.
- Restaurantes: Abiertos al interior con un 50% de ocupación máxima o 200 personas, lo que sea menor.
- Centros comerciales (incluidos tianguis y centros comerciales bajo techo): Se abren en interiores a plena capacidad con modificaciones; las áreas comunes deben permanecer cerradas y las áreas de comida tendrán una capacidad reducida.
- Eventos en vivo al exterior que incluyen asientos asignados: Solo se permiten asistentes que vivan en el estado. Las modificaciones y limitaciones en capacidad se basarán en el tamaño del lugar del evento.

Imperial County Announces Covid-19 Vaccine Eligibility for Individuals 16 and Older

IMPERIAL COUNTY –Imperial County Health Officials have announced that beginning tomorrow, April 9th, COVID-19 vaccine eligibility will be extended to all Imperial County residents 16 years of age and older. Registration for appointments will continue to be available through the State of California’s My Turn system. For providers receiving vaccine from a federal program, their information can be found on www.vaccinefinder.org. Individuals may also check with their local providers to inquire about vaccine availability and appointments.

“We’ve seen a significant drop in the number of COVID-19 cases nationally, statewide and locally due in large part to the number of people who have received the COVID-19 vaccine,” stated Stephen Munday, Imperial County Health Officer. “Eligible residents should get vaccinated as soon as possible and with whichever vaccine is available. Increasing the number of individuals who receive the COVID-19 vaccine is an important step in ending the pandemic.”

Earlier this week, having met significant milestones in the number of Californians vaccinated, the State announced updates to the California Blueprint for a Safer Economy. The update allowed Imperial County to move the Orange Tier. Subsequently, an Amended Health Officer has been developed reflecting these changes. In addition to those guidelines and restrictions issued by the State, the amended order includes the following guidance.

- a. Singing, chanting, shouting, and the playing of wind instruments (any instrument played by the mouth, such as a trumpet or clarinet) shall be permitted in outdoor public or private venues where the performers are able to maintain a distance of at least twenty (20) feet from the audience.
- b. The playing of wind instruments is prohibited in all indoor public and private venues. Singing, chanting, and shouting shall be permitted in indoor public or private venues if the following conditions are met:
 - All performers and audience members wear a face covering at all times.
 - All performers and audience members that are not from the same household are able to maintain a minimum of six (6) feet of social distancing at all times.

The amended health officer is available on the Imperial County Public Health Department website. Guidance related to playing wind instruments indoors may change soon as the State plans to release new guidance on April 15th. Once those changes are announced, the local Health Order will be amended to reflect the new guidance and information will be shared with the Public.

Imperial County residents are urged to continue to follow COVID-19 safety precautions including wearing face coverings, staying at home when sick, practicing appropriate distancing, avoiding gatherings, except as permitted, and getting fully vaccinated when vaccine becomes available.

El Condado de Imperial Anuncia la Elegibilidad para Recibir La Vacuna COVID-19 De Las Personas Mayores De 16 Años

CONDADO DE IMPERIAL -Los funcionarios de salud del Condado de Imperial han anunciado que a partir de mañana, nueve de abril, la elegibilidad para recibir la vacuna COVID-19 se extenderá a todos los residentes del Condado de Imperial de 16 años o más. La inscripción para las citas seguirá estando disponible a través del sistema del Estado de California "My Turn". Para los proveedores que reciben la vacuna de un programa federal, su información se puede encontrar en www.vaccinefinder.org. Las personas también pueden consultar con sus proveedores locales para informarse sobre la disponibilidad de vacunas y las citas.

"Hemos visto una caída significativa en la cantidad de casos de COVID-19 a nivel nacional, estatal y local debido en gran parte a la cantidad de personas que han recibido la vacuna COVID-19," afirmó el Dr. Stephen Munday, Oficial de Salud del Condado de Imperial. "Los residentes elegibles deben vacunarse lo antes posible y con cualquier vacuna que se encuentre disponible. Aumentar el número de personas que reciben la vacuna COVID-19 es un paso importante para poner fin a la pandemia."

A principios de esta semana, habiendo alcanzado una meta significativa en el número de californianos vacunados, el Estado anunció actualizaciones del Plan de California para una Economía más Segura. La actualización permitió al Condado de Imperial avanzar al Nivel Naranja. Posteriormente, se desarrolló una enmienda oficial de salud que refleja estos cambios. Adicionalmente a estas pautas y restricciones emitidas por el Estado, la orden enmendada incluye la siguiente guía.

A. Se permitirá cantar, canto grupal, animar (porras) y tocar instrumentos de viento (cualquier instrumento que se toque con la boca, como una trompeta o un clarinete) en lugares públicos o privados al aire libre donde los intérpretes puedan mantener una distancia de al menos veinte (20) pies de la audiencia.

B. Está prohibido tocar instrumentos de viento en todos los lugares interiores, ya sean públicos y privados. Se permitirá cantar, canto grupal y animar (porras) en lugares cerrados públicos o privados si se cumplen las siguientes condiciones:

- Todos los artistas intérpretes o ejecutantes y los miembros de la audiencia usan una máscara en todo momento.
- Todos los artistas y miembros de la audiencia que no sean del mismo hogar pueden mantener un mínimo de seis (6) pies de distanciamiento social en todo momento.

La enmienda oficial de salud está disponible en el sitio web del Departamento de Salud Pública del Condado de Imperial. La guía relacionada con tocar instrumentos de viento en interiores puede cambiar pronto, ya que el Estado publicará una nueva guía el día 15 de abril. Una vez que se anuncien estos cambios, la Orden de Salud local se modificará para reflejar la nueva guía y la información se compartirá con el público.

Se les pide a los residentes del Condado Imperial que continúen siguiendo las precauciones de seguridad de COVID-19, incluido el uso de cubrebocas, permanecer en casa cuando estén enfermos, practicar el distanciamiento apropiado, evitar reuniones, excepto según lo permitido, y vacunarse por completo cuando la vacuna esté disponible.

HPUD Children's Park Committee Meeting Outcome

1. The second Park Committee meeting was conducted on March 30, 2021 via Zoom. The participants were:

2. The following items were reviewed at the committee meeting:

- a. Park Layout Options

- Park Committee agreed that Option 2 of the Park Layout Option (attached) be recommended to the Board. Board action will be required for the selection of Option 2.
- The committee unanimously agreed that ADA accessibility be a priority. Rubberized surface installation and sidewalk improvements will be included in the Base Bid to maintain an ADA accessibility throughout the park.

- b. Splash Pad Facilities

- Overall, the committee members were pleased with the selected splash pad facilities with the following suggestions:
 - 1) Spring Garden (Ladybug, ants, butterflies, etc.)/Nature theme was suggested for the amenities and color scheme.
 - 2) Gecko Ground Sprays to be altered with ladybug/butterfly/spring garden like themed ground sprays, if possible.
 - 3) Water Weaver 2 is to be added
 - 4) Rock features will be avoided as they may be a slipping hazard.

- c. Playground Options

- The Committee's focus is to make the best use out of the splash pad with the limited budget. It was agreed that a safe rubberized surface be installed with a small playground equipment with a shade. The Vendor will be contacted for the options for the toddler playground (2-5 yr age group) or standard playground (5-12 yr age group) with a budget of \$50,000 (including material and installation cost – turn-key).

- d. Additional Funding Opportunity
 - APCD application will be submitted for the alley improvements. Landscaping improvements at Children’s Park can be funded through the APCD grant.
 - HPUD/THG is also looking into applying for additional funding opportunities through other entities such as AARP, CDBG, USDA, etc.
- e. Other Items Discussed
 - The existing pedestrian gate at northwesterly entrance leading to the proposed splash pad and playground area shall be closed or double gated so that children will not run out from the park.
 - Security lighting be considered for the park to mitigate dark areas.
 - Community Feature
 - 1) Story Boardwalk with Story Trivia along the alley improvements
 - 2) Mural on the Restroom Building Wall
 - 3) Art elements– Nature/Spring Garden theme to be carried through
 - Paw prints/stamped concrete along the alley improvements.

To Be Reviewed by HPUD Committee

1. Playground Facility to be decided.
2. The committee discussed the budget shortfall and is seeking additional funding sources.

List of Items to be Provided by THG

1. Cost Estimate to prepare Grant Application(s) for different grants available.
2. Cost Breakdown of the Children’s Park Facilities with items segregated for the APCD Grant application.
3. Playground Equipment Options.

Site Design

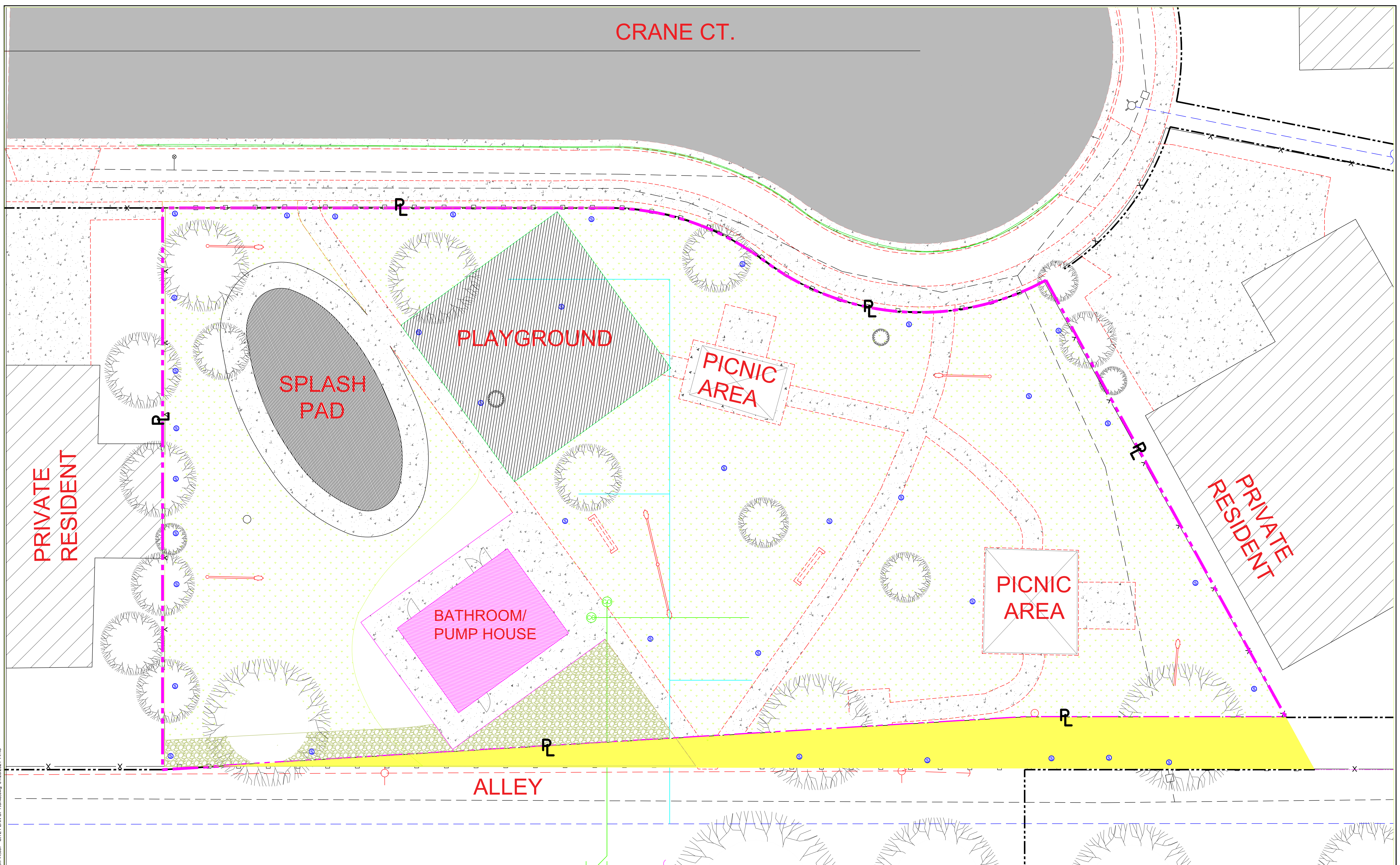
1. After the HPUD Board approves the site layout option (Option 2), the final site design will commence. The site design will include the foundation design for the restroom and splash pad, sidewalk design, landscape design, utility design (electrical, water and sewer).
2. The pre-selected vendor needs to provide the updated water demand and electrical load to move forward with the design of the facilities. The pre-selected vendor provided the water demand of 73 GPM (per the selected features by the vendor – subject to change per the HPUD Committee’s selection of the facilities) and the electrical load as shown in the table below for the vendor selected apparatus.

Cost Overrun and Bidding Procedure to Review

1. HPUD/THG will need to verify the bidding procedure acceptable by the funding agency. The committee needs to decide on the bidding procedure of the project, i.e. direct purchase through “piggyback” method and hiring a prime contractor through the normal bidding method; or a combined bid whereby the prime contractor will furnish the playground equipment and complete all improvements.
2. HPUD/THG will continuously seek additional funds to cover the cost overrun.

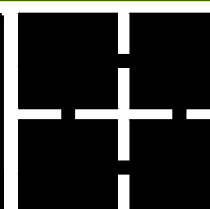

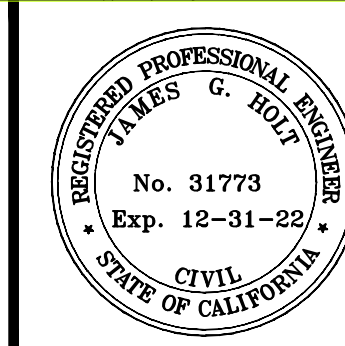

Pursuant to the requirements of the CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) and the County's "RULES AND REGULATIONS TO IMPLEMENT CEQA," the Imperial County Environmental Evaluation Committee (EEC) held a public hearing on **February 11, 2021** at **1:30 p.m.** in the Board of Supervisors Chambers, 940 Main Street, El Centro, CA to hear the project(s) listed below and rendered a CEQA determination(s), e.g., Negative Declaration, Mitigated Negative Declaration or an Environmental Impact Report. (NOTE: Interested parties have ten (10) calendar days to appeal the EEC's CEQA determination from the date of the public hearing)

Mitigated Negative Declaration Assessment #19-0033: Applicant: Heber Geothermal Company/ Ormat Nevada Inc. Applicant is proposing Conditional Use Permit (CUP) #19-0028 to amend the existing CUP #15-0013, and expand the Heber 1 facility by installing two new Ormat Energy Converters (OEC) and reconfigure two existing OEC into a combined two-level unit and ancillary equipment for a project's total production of 52 MW net and 78.2 MW gross. This application also proposes to extend the permitted life of the Heber 1 to 30 years.
