Subject: October 2021 Monthly Report

On the billing cycles ending on the 21st of October 26,699,000 gallons of water were used by our consumers, an average of 890,000 gallons was used per day.

On October 13, 2021 collected fourth quarter TTHM's samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on October 26, 2021 and were below the maximum contaminant level (MCL) for the both sites. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and for the 4th of 2021 we attained a RAA of 54 ppb for the Mc Cabe Cove site and 39 ppb for the Little Field site. Heber Public Utility District is in compliance with State and Federal water regulations.
