SUBJECT: Authorize the General Manager to Execute the Contract for the Construction of Children's Park Improvement Project to Three Peaks Corp.

ISSUE: Shall the Board of Directors authorize the General Manager to execute the construction contract for Children's Park Improvement Project to Three Peaks Corp?

GENERAL MANAGER'S RECOMMENDATION:

It recommended that the Board of Directors not authorize the General Manger to execute the construction contract for Children's Park Improvement Project.

FISCAL IMPACT:

The Heber Public Utility District will need to commit all of the gap funds in order to approve the construction contract. The District can continue to search for funding sources such as grants and/or loans after committing Parks Funds. The Negative Impact to the Parks Funds will be the full gap amount of \$874,430.

The current reserve policy states that the District must maintain 6 months of expenditures in reserves. Current Reserve Policy for Parks is below.

BACKGROUND:

The grant for this project was award for \$700,000. The project components must remain in the project to secure funding. The bid came in at \$1,565,899, and additional project cost will be needed to meet county's parking requirements.

Attached to this report you will find a report prepared by our engineer, Ms. Fumi Galvan. It includes a letter summary of the bid opening, bid tabulation form, and progress report.

The low bid was Three Peaks at \$1,565,899. The county of Imperial is requiring that we construct 2 ADA compliant parking spaces, which will add about \$100,000 to the project brining the total project cost to \$1,665,899. The Project Budget is below:

DISCUSSION:

Staff has made several inquiries to secure additional funds. We were successful in getting an additional \$200,000 from the Heber Community Foundation. The table below shows the funding sources, amount and gap that must be committed prior to approval of the construction contract.

CONCLUSION:

The Board has the following Options:

 Authorize the General Manager to execute the contract for construction, which will cause the Parks Fund to not meet the six-month reserve requirement (according to HPUD policy) by the end of FY 2024-25 at project completion. HPUD could still secure additional funding that would require less gap funding from HPUD.

- 2) Authorize the HPUD staff to rebid the project and hope to secure additional funding and a lower bid. This will extend the Agreement timeline, but should not be an issue as other agencies in the State are experiencing high cost. There will be additional project cost to rebid as it will be additional consultant time, and the contractor expects higher material costs.
- 3) Reject the project, return the State Park funds (already received by HPUD) in the amount of \$100,360 and pay all remaining invoices from The Holt Group. Staff estimates the total investment in the project to be approximately \$120,000.

As this project must rely on HPUD parks funds to complete, staff is not recommending approval at this time. Option 2 or 3 is recommended.

- A. Service shall generally be from dusk to dawn and will be considered as 4,190 hours per year or 349 hours per month.
- B. For District-owned installations, rates are applicable to standard street and highway lighting equipment mounted on wood poles or steel street light standards with overhead circuits only. When underground services or steel poles are requested, the customer will be required to furnish and install the necessary equipment for service and be responsible for replacement when it has been

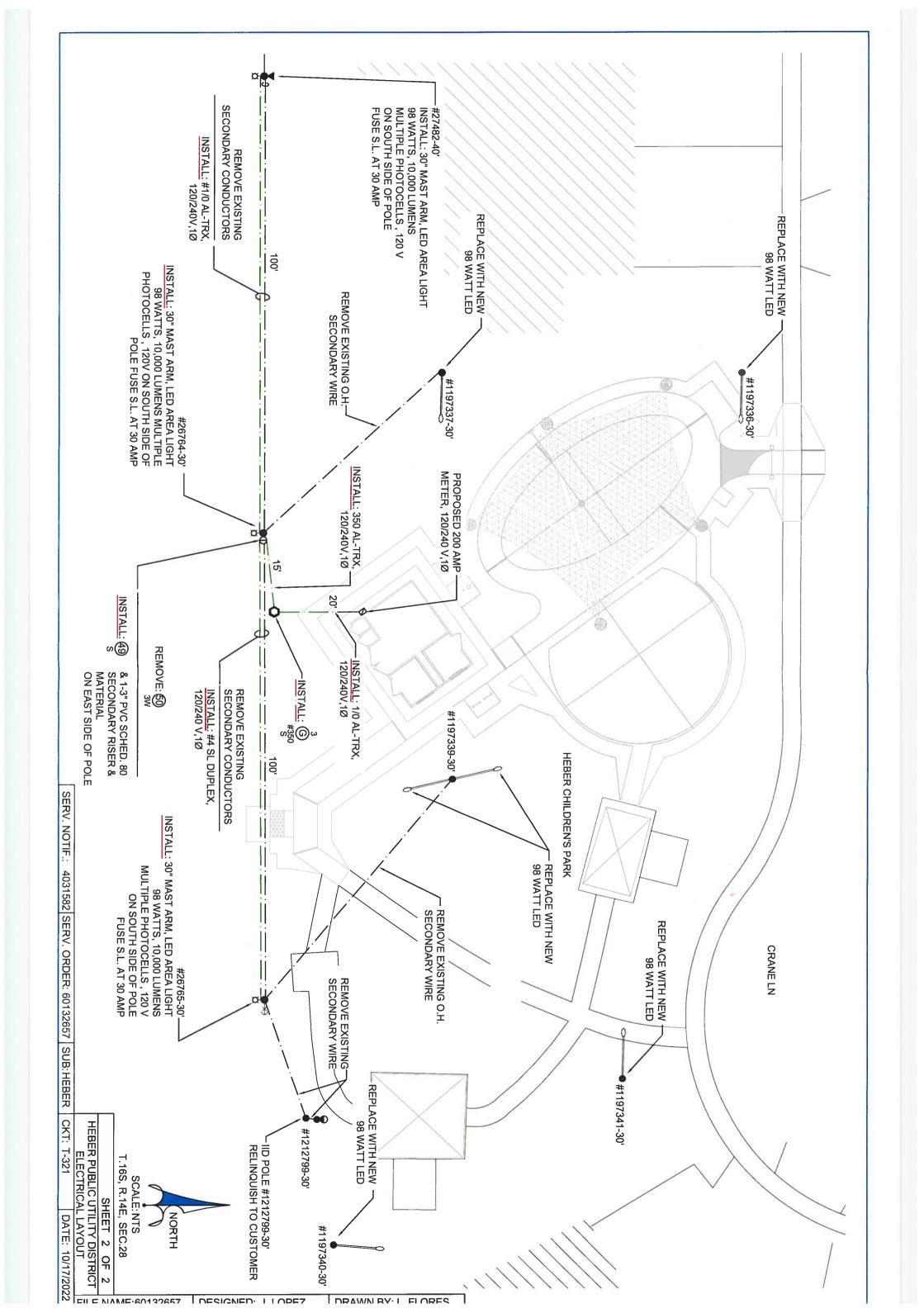
determined that such replacement is necessary. Any payment advances made for other than a standard installation will not be refunded.

- C. For an underground service installation and maintenance, the customer will be required to furnish and install the necessary underground wiring, ducts for circuits, pullboxes, conduits, substructures including foundations and anchor bolts, excavating, backfilling and restoration of the pavement in accordance with the District's specifications. Any installations over the above standard provisions may be installed by agreement between the parties provided the customer pays all costs incurred. All underground maintenance, wiring, ducts for service, pullboxes, conduits, substructures including foundations and anchor bolts, excavating, backfilling and restoration of pavement, underground infrastructure, and steel poles and its installation costs are the responsibility of the customer.
- D. Service will not be furnished under this schedule where, in the opinion of the District, an undue hazard or expense will be involved because of locations, mounting height, or other reason. The installation of street lighting equipment and facilities is contingent upon the District obtaining easements, rights of way, clearances and highway permits satisfactory to the District for the required poles, lines, equipment and facilities.
- E. LED fixtures will only be installed at new locations, or where existing fixtures must be replaced due to failure, and at locations where suitable service is available as determined by Imperial Irrigation District. High-pressure sodium vapor street light fixtures will be changed to LED fixtures if the above conditions are met. Fixture replacements will be made by attrition only and when it does not interfere with other work. Cost for replacement of lights to LED fixtures requested by the customer before it is needed, shall be the responsibility of the customer. The customer shall be responsible to apply for replacement with the District business office.
- F. Vegetation caused by the customer is the responsibility of the customer for installation of new lights or for maintaining existing lights.
- G. Outages will be reported by the customer. Lamp maintenance will be done during regular working hours or as soon as reasonably possible after the customer has notified the District. Monthly bills will not be adjusted for reasons of any outages. Billing will be adjusted to accommodate any fixture size changes or installations.
- H. <u>Regulations Governing the Sale and Use of Electric Energy</u>: Service under this rate schedule is subject to the District's Regulations Governing the Sale and Use of Electric Energy.

Good Morning Laura,

I had a conversation with Mr. Joel Lopez with IID and Juny to go over the alley and park lighting. Here is the summary and findings from the phone conversation:

- 1. IID Joel Lopez
 - a. IID can independently provide the installation of the alley lighting and switch the existing light bulbs inside of the park with new LED light bulbs. IID will not provide covers for the lights. The light expands in an egg shape and it reaches both ways, not just the alley.
 - b. The IID work will not interfere with the work proposed within the Children's Park as they are all overhead work. (Undergrounding of the existing electrical lines within the park can be done during the Children's Park improvement project construction).
- c. The cost proposed by the IID ("Children's Park Cost letter" attached to this email), in the amount of \$6,199.25, will expire this year and be increased (double or more) if the work will be completed in 2023 or later. 2. Concerns/Discussion
 - a. Alley belongs to the County of Imperial currently and most likely, we will need the County's approval to install the lights. Based on the experience with the Jiggs Johnson Park lighting project, we will need to get consent from each neighboring resident along the alley. Would HPUD be able to get these consents?
 - b. The lumens proposed are 10,000 at 98W. If HPUD prefers lower lumens, as long as it is listed on the attached pdf, "SL1-Eff. 05.2019...," IID can provide them.

Mr. Joel Lopez needs to have a direction in a month so that he can move forward or put it on hold. Please let me know if you need more information or need assistance with regard to this matter. Thank you.

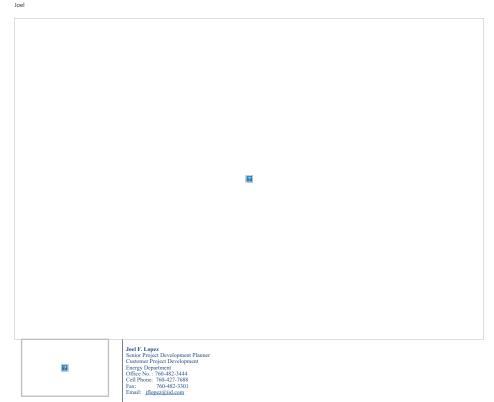

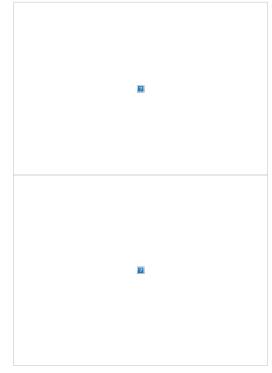

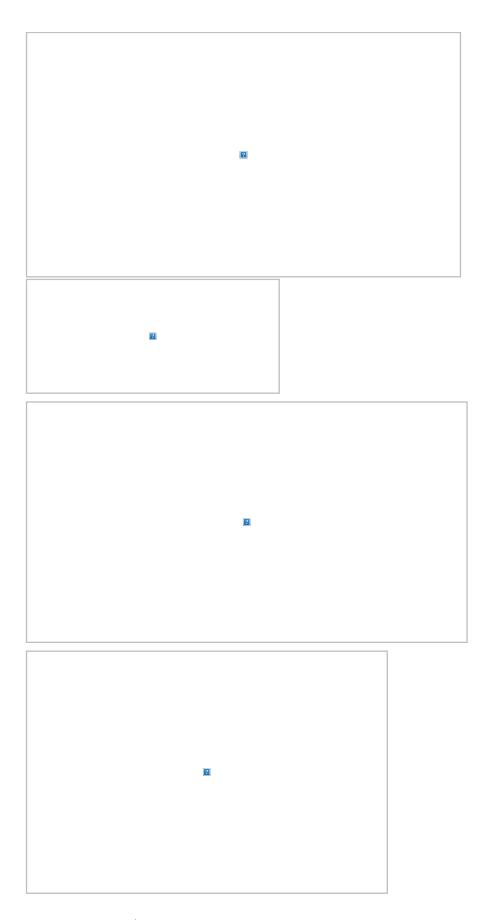
