Subject: November 2023 Monthly Report

On the billing cycles ending on the 21st of November 24,697,000 gallons of water were used by our consumers, an average of 823,000 gallons was used per day.

On November 15, 2023, collected the monthly Trihalomethanes (TTHM's) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on November 29, 2023 and were below the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 67 ppb for the Mc Cabe site and 51 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.
