Subject: February 2024 Monthly Report

On the billing cycle ending on the 22nd of February 19,618,000 million gallons of water were used by our consumers, an average of 632,000 thousand gallons was used per day.

On February 11, 2025, collected Trihalomethanes (TTHM's) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on February 18, 2025 and were below the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 55 ppb for the Mc Cabe site and 42 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.
