WHEREAS, the Heber Public Utility District (“District”) is responsible for maintaining and operating facilities and infrastructure necessary to provide essential public services to the community; and

WHEREAS, the District has identified the need to purchase a mixer to support operational and maintenance activities that contribute to the efficiency and effectiveness of District operations; and

WHEREAS, the purchase of a mixer will assist the District in performing necessary operational functions and improving service delivery to residents within the District; and

WHEREAS, the Board of Directors finds it to be in the best interest of the District to authorize the General Manager to procure such equipment in a timely manner; and

WHEREAS, the total cost of the mixer purchase shall not exceed \$24,671 and the purchase shall be made in accordance with District purchasing policies and applicable procurement requirements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Heber Public Utility District as follows:

1. The Board of Directors hereby authorizes the General Manager to purchase a mixer necessary for District operations.
2. The total cost of the mixer shall not exceed \$24,671.
4. Funding for the purchase shall come from the appropriate budget allocation.





SUBJECT: Authorize the General Manager to Purchase a Mixer not to Exceed \$24,671

BACKGROUND

The proposed resolution authorizes the General Manager of the Heber Public Utility District to purchase a mixer for the Wastewater Treatment Plant necessary for District operational and maintenance activities, with a total cost not to exceed \$24,671. The equipment will support the District's ability to efficiently complete maintenance and infrastructure-related work that benefits public facilities and services. Authorizing the General Manager to proceed with the purchase ensures the District can acquire the equipment in a timely manner while remaining within the approved budget limit. The purchase will be conducted in accordance with District procurement policies and funded through the appropriate budget allocation approved for operational equipment and maintenance needs.
